**Direct Cremation \$1175 to \$1260**

The charge for a direct cremation includes the removal of remains from the place of death Hospital, Medical Examiner, Nursing Home, Hospice facility (within a 50 mile radius of Knoxville), use of thermal shelter facilities for 48 hours, local transportation to crematory, crematory fee, necessary authorizations, cremation permit and online basic services of the funeral director and staff, and 1 Certified Death Certificate. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard, or composition materials (with or without an outside covering.) The containers we provide are fiberboard or composition materials.

- 3. With container selected from our funeral home (casket price not included)..... \$1175
- 4. Death at Home requires additional staff for removal (75 per extra staff) .....\$1260

Viewing and Witnessing cremations will still pick remains up the following Thursday at the Cremation Society address between 3:00pm and 5:00pm unless scheduled otherwise.

We require that families take receipt of cremated remains within (30) days of the date of Cremation.

**Basic Services of Funeral Director & Staff.....\$395**

Our basic services fee includes, but is not limited to: the services of our online arrangement and staff to respond to the initial request for service; arrangement conference with the family/ responsible parties; arrangement of services requested; preparation/ filing of necessary authorizations, documents and permits; customary sheltering of remains; recording vital statistics.

In addition, this fee includes a proportionate share of overhead expenses relative to operating our facilities, such as an answering service to respond 24 hours a day to calls; accounting and billing, administrative and secretarial costs; insurance and legal expenses, governmental compliance; maintenance and utility expenses, equipment and inventory expenses and similar overhead expenses necessary to operate Cremation Society of East Tennessee.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.

This fee is already included in our charges for direct cremations.
